

Terms of Use

1. Agreement to Terms

By accessing or using the website <https://itbuild.app> (the "Site"), you agree to be bound by these Terms of Use ("Terms"). If you do not agree to these Terms, do not access or use the Site.

IT Build Group operates under the legal entity **VIA SUPREME (HK) LTD**, a company registered in Hong Kong SAR ("Company," "we," "us," or "our").

These Terms constitute a legally binding agreement between you and VIA SUPREME (HK) LTD. We reserve the right to modify these Terms at any time, and your continued use of the Site following any changes constitutes acceptance of the revised Terms.

11.3 Waiver of Class Actions

You agree that any proceedings to resolve disputes relating to these Terms or the Site will be conducted on an individual basis and not in a class, consolidated, or representative action.

12.1 Termination by Us

We may terminate or suspend your access to the Site immediately, without prior notice or liability, for any reason whatsoever, including but not limited to:
